Statements concerning award

To whom available

One or more Mountain View High School graduates who wish to attend an accredited institution of their choice on a full-time basis.

Restrictions

The fields of General and Vocational Agriculture or Physical Education may not be pursued with the benefits of this scholarship.

Value of Scholarship (Financial amount can vary)

This scholarship will extend over the normal two or four years of college attendance so long as the recipient continues to meet the high standard established for the holders of this award. The recipient shall maintain a "B" average. The amount of the scholarship will be determined by the need of the successful candidate after taking into account the financial resources of parents. (Parents must be willing to submit information regarding financial resources.)

Eligibility

The nominee should take into consideration the following factors:

1. Scholastic ability,
2. Imagination, and
3. Personal characteristics, including evidence of sense of responsibility and aptitude for leadership.

The same criteria will be the bases on which the successful nominee will be chosen.

The Selectors (Committee)

1. Superintendent and/or Principal,
2. School Counselor, and
3. Instructor

Notice of Intention

The student or students receiving this scholarship must notify the Superintendent of Mountain View schools of his intended field of study. (This is to qualify under the restrictions clause). The Notice of Intention must be given by the middle of the sophomore year in college. It is further desired that the student should give moral commitment to the completion of the college course by pledging himself to its completion.

College Requirements

Maintain a minimum 2.75 grade point average (GPA), maintain continuous college enrollment (enroll every fall and spring semester, and maintain satisfactory academic progress (SAP) by enrolling in and completing a full-time course load each semester.

Regaining Eligibility

If a student loses the scholarship due to failure to maintain either the required GPA, continuous enrollment or satisfactory academic progress, scholarship funds will be rescinded until the first academic semester/term occurring after the appropriate eligibility requirement has been restored.
